9. I, SPC Kevin Vogel, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

Our Squad element was taking a Convoy South on Detroit, and there was another military traveling North on Detroit Around 1145 I heard Sgt. Baker come over the radio and say his vehicle was taking Small arms fire toward the front of the Convoy. At that point all the TCN drivers stopped their trucks. Then my team and 33c team proceeded up to where the 33A element was taking fire. As we made our way up we were taking fire to our vehicle, but could not actually see where it was coming from. My gunner began firing 50 cal rounds to our right because he could here rounds hitting our vehicle from that side. Once we made to the front of the convoy we had a transmission come over the radio from the Raven element saying that they were taking fire from all sides. At that point my TC instructed me to turn my truck around and head back to help pull security with the raven element. When we arrived at there point there was a soldier waving me forward to help out with their wounded. Then me and my TC got

and helped get the wounded soldier into our truck and took him a safe area. We drove about 2 miles up the road while taking fire the whole time, once up the road we met up with our 33 A element and had them radio for medevac. We left the wounded soldier with that other element, and proceeded back to the Raven element. Once there we escorted another soldier into our vehicle who had an abdomen wound, and needed to be flown out, so we rushed him up to the safe area where we met up with the chopper medevac and helped load the soldier into the chopper. By this time the firing had stopped and began checking area for more wounded.
